A **RESOLUTION TO:** relocate all six vending machines to advocate for the renovation of the take 5 lounge eating area.

# THE MADONNA UNIVERSITY STUDENT SENATE ENACTS:

WHEREAS, the space made would be better used for student recreational and academic use, and;

WHEREAS, It is apparent that some students that live in the West Wing dormitories have to travel a distance to the nearest vending machine, and;

WHEREAS, the use of these vending machines would be constant in multiple new areas, and;

WHEREAS, these new locations being one snack machine and one pop machine, from the Take 5 Lounge, to the ground floor of the West Wing, A snack machine and pop machine would also be relocated in proximity to the men's bathroom in the 2100 Graduate hallway, and lastly two vending machines directly to the left of the Student Life storage room, and;

RECOGNIZING, that moving the vending machines to their new locations would make room for the renovation of the Take 5, and;

WHEREAS, giving additional snack and beverage options to students and staff around the entire campus, and;

#### Policy Proposal for Vending Machine Relocation

#### **A RESOLUTION TO:**

Relocate all 6 of the vending machines to advocate for the remodeling of the Take Five Lounge eating area.

**RATIONALE:** The rationale behind relocating the vending machine is so that the space made would be better used for student recreational/academic use. It is apparent that some students that live in the west wing dormitories have to travel a distance to the nearest vending machine, simply because there are n vending machines present in the west wing.

This school year, the West Wing was opened to a larger population of students to live if they wanted a private room. Through this I believe that relocating one snack machine and one pop machine, from the Take Five Lounge, to the ground floor of the West Wing would be in the best interest of the students. They both would be in a well light area and easily accessible to all student including handicapped. Along with the relocation to the West Wing, there are two more areas that would suitable to station the remaining four vending machines.

The second area would be located in the 2100 Graduate school hallway. A snack machine and pop machine would also be relocated in proximity to the men's bathroom. This would be a good location because of the many offices and classrooms that are within a short radius of the area. It would provide students and staff with an easier access to food and drink options.
