My younger sister and I have been volunteering there for several years (admittedly, my sister more than I) and it was she who brought the issue to my attention. Due to the rough economic status of Monroe County, there are not enough funds to keep the Historical Museum running. According to Bonnie Finzel-Doster, a volunteer there, the museum is trying to run on thirty thousand dollars a year. Last year the director had to be laid off because there was no longer any money to pay for his position, and now there are only two full-time employees working there: An archivist and an educational promoter. Because of this, the museum proposed a millage for all house-owners in Monroe County that will be voted on August 7, 2012.

The millage, if passed, would last for ten years. House-owners in Monroe would pay between five and seven dollars per year to reach the total sum of five hundred and sixty-nine thousand dollars (Cousino, D., 2012). With this money, Finzel-Doster said, the museum hopes to hire at least four more full-time employees and keep the museum open all week. Currently it is only open Wednesday to Saturday from 10 a.m. to 5 p.m. ("Monroe County Historical Museums").
